### 1. Application

These terms apply to this sale and all statements made by Prints & The Revolution in brochures, price lists, adverts, quotations, on the internet or verbally. Any variations to these terms must be confirmed by Prints & The Revolution in writing. Any other Terms and Conditions are excluded. Placing your order means acceptance of these terms. These terms do not apply to Product purchases from a reseller or distributor nor is it a reseller or distribution agreement.

### 2. Price / Payment / Payment Terms

Products prices, tax, and shipment are as shown at [www.printsandtherevolution.com](http://www.printsandtherevolution.com) and your order confirmation. Changes to exchange rates, duties, insurance, freight and purchase costs may cause Prints & The Revolution to adjust prices accordingly. Payment will be made before supply and can be done through a secure on-line payment system which is integrated within [www.printsandtherevolution.com](http://www.printsandtherevolution.com) or by bankwire.

Payment timing is of the essence. Prints & The Revolution may suspend deliveries until full payment for that order.

Until full payment has been made the entire ownership of the artwork will remain with the artis and/or Prints & The Revolution

### Delivery

Prints & The Revolution tries to deliver the product within 15 days after receiving payment for this specific product. The maximum delivery period is 30 days. The place of delivery is stated in the Order Confirmation.

### Acceptance

When you receive Product you must inspect it for any defects or non-conformity within 7 days. After this period, you will have accepted Product. If Prints & The Revolution agrees to the return of Product at its choosing, it must be in its original condition with packaging, a return note and proof of purchase; the return costs may also be payable by you.

### 3. Warranty

Unless otherwise stated, Prints & The Revolution guarantees to you that Prints & The Revolution Products will be free from defects upon delivery. Should Product be defective upon delivery, Prints & The Revolution will repair or replace Product within a reasonable time. All reasonable care and endeavour shall be used to resolve problems within a realistic period in the circumstances. Prints & The Revolution does not give a warranty guarantee protection for:

damage caused by incorrect removal of packaging, use, modifications or repair by any unauthorised 3rd party or yourself, caused by any party (except Prints & The Revolution) or other external force

You must provide Prints & The Revolution with all reasonable courtesy, information, cooperation, facilities and access to enable Prints & The Revolution to perform duties, failing which Prints & The Revolution shall not be obliged to perform any Service or assistance.

### 4. Force Majeure

Prints & The Revolution is not liable for delays in performance (incl. delivery) caused by circumstances beyond its reasonable control and will be enleadind to a time extension for performance; examples include strikes, terrorist acts, war, supplier / transport / production problems, exchange fluctuations, governmental or regulatory action and natural disasters. If this lasts more than 2 months, this Agreement may be terminated by either party without compensation.

## **5. Termination**

Prints & The Revolution may terminate this Agreement with immediate written notice if you: 1) fail to pay on time, 2) breach or Prints & The Revolution suspects you have breached export control laws. Either party may terminate if the other: 1) commits a material or persistent breach of this Agreement and fails to remedy this within 30 days of written notice from the other; or 2) becomes insolvent or is unable to pay debts as they fall due.

## **6. Your obligations as a Customer**

You are responsible for: your own choice of Product and its suitability for purpose and your telephone & postal charges in contacting Prints & The Revolution, if any:

You must provide Prints & The Revolution with all reasonable courtesy, information, cooperation, facilities and access to enable Prints & The Revolution to perform duties, failing which Prints & The Revolution shall not be obliged to perform any Service or assistance.

## **7. Data Protection**

Your data will be held and/or transferred in strict accordance with the applicable data protection laws and Prints & The Revolution's data protection registration. ## **8. Consumer Rights**

If you are a Consumer you may cancel your purchase at any time within 7 working days of receipt without cause and receive a refund of the Price paid. The shipping costs will have to be borne by you.
